Attention for Travelers to the Republic of the Congo

The Embassy of the Republic of the Congo wishes to remind all individuals planning to travel to the Republic of the Congo that visa fees are non-refundable in the event of a change of plans or a visa denial. We strongly encourage all travelers to carefully review the visa requirements and procedures before submitting any documents or making any payments.

Visa application drop-offs are accepted on **Tuesdays and Fridays from 1:00 p.m. to 4:00 p.m.**

- A passport or travel document valid for at least 6 months after your travel dates

Business Visa Requirements:

- A completed visa application form
- A passport or travel document valid for at least 6 months after your travel dates
- A round-trip flight reservation
- A hotel reservation in the Republic of Congo, or an invitation letter/accommodation certificate signed by the relevant Congolese police authority (if applicable)
- A letter clearly stating the nature of your business and your travel itinerary
- A formal invitation letter from the host organization in the Republic of Congo (if applicable) A mission letter from your employer in Sweden
- A recent bank statement showing proof of sufficient funds—minimum 2,000 SEK per day for the duration of your stay
